WHAT IS A TREATMENT COURT?

A Treatment Court is a judicially-supervised collaborative court docket that combines treatment for substance use disorders and, often, mental health challenges with careful monitoring and supervision as an alternative to standard sentencing.

VETERANS TREATMENT COURTS

- Most Veterans return home strengthened by their military experience.
- Veterans Courts are for Veterans whose untreated substance use disorders and often combat-related mental health challenges have led to involvement in the criminal justice system.
- Program at least one year long.
- Participants are high risk for re-offense and high needs for services.
- Treatment is required, generally from VA Clinics or Vet Centers.
- Frequent, observed and random drug testing required.
- Participants are usually assigned a Mentor.

VETERANS COURT MENTORS

- Volunteer Veterans from community
- "Trusted Friend," not counselor.
- Annual training plus monthly meetings.
- Application process includes criminal background check.
