

University of Montana – Explanation of Transcript

NAME OF THE INSTITUTION

The University of Montana was opened September 1895. The name was changed to The State University of Montana in July 1917, when all state institutions were organized into a "University of Montana System." In July 1935, the name was changed to Montana State University. In July 1965, the name again became University of Montana under the state system, re-titled "Montana University System."

CALENDAR AND CREDIT

1. All colleges, schools and departments, except the School of Law:

- a. 1895-Spring 1918. Semester System (18 weeks)
 - (1) 1895-1898. Credit in terms of a "Course," or "Partial Course." A full course equivalent to 5 semester hours credit.
 - (2) 1898-1905. "Course" credit continued. Value changed to 4 semester hours credit.
 - (3) 1905-1918. Semester hours credit (1 credit = 1 hour of lecture, or 2½ hours of laboratory per week).
- b. 1918-1992 and Summers. Quarter System (12 weeks). (1 credit = 1 hour of lecture, or an average of 2½ hours of laboratory per week).
- c. 1992-Present. Semester System (15 weeks) (1 credit = 1 hour of lecture or an average of 2½ hours of laboratory per week).

2. School of Law

- a. 1911-Spring 1918. Semester System (18 weeks). Credit in semester hours.
- b. Fall 1918-Spring 1955. Quarter System (12 weeks). Credit in quarter hours.
- c. Fall 1955-Present. Semester System (16 weeks). Credit in semester hours.

A maximum of 60 quarter or 40 semester credits earned on the Pass/Not Pass system allowed toward the bachelor's degree. 1970-Summer 1996. A maximum of 18 semester credits allowed Autumn 1996-2004. Changed to Credit/No Credit (CR, NCR) Autumn 2004-present.
4. No Credit (Symbol NC or NCR). Students enrolled in English Composition are graded by the traditional letter grades of A, B, C, D, F or are given NC or NCR for no credit. The no credit grade does not affect grade point average. 1985-2004; grade NCR Autumn 2004-present.
5. School of Law only. High Competent/Competent (symbols HC and CM) are not counted in grade average. Earned credits will count toward clinical requirements.

Missoula College University of Montana Explanation of Transcript

NAME OF THE INSTITUTION

Missoula College University of Montana (University of Montana College of Technology) was renamed as approved by the Montana Board of Regents in Autumn Semester of 2012. Missoula College began in 1966 and was recognized by the state of Montana, Missoula County High School, and the Missoula community as the Missoula Area Vocational Education Center in 1967. In 1969 the Montana Legislative Assembly designated the Missoula Center as one of five Vocational Technical Centers in the state. In 1969 the Missoula Vocational Technical Center (also known as Missoula Technical Center) was accredited by the Northwest Association of Schools and Colleges. In 1994 the Missoula Vocational Technical Center became a College of Technology and one of several colleges of the University of Montana in Missoula. Specific programs of the UM College of Technology (Missoula Vocational Technical Center) were and are accredited by state and national professional accrediting organizations.

CALENDAR

From 1966 to Summer term 1989, the school functioned on a quarter system based on contact hours. From 1990 to present a 15 week semester and credit hour system is used.

ACCREDITATION

Missoula College University of Montana (UM College of Technology—2012; Missoula Vocational Technical Center—1994) is accredited by the Northwest Commission on Colleges and Universities (Northwest Association of Schools and Colleges). The Missoula College has been accredited since 1969.
