Named for the University's first President, this society includes individuals who have committed a planned gift to benefit The University of Montana. Membership is active throughout a member's life.

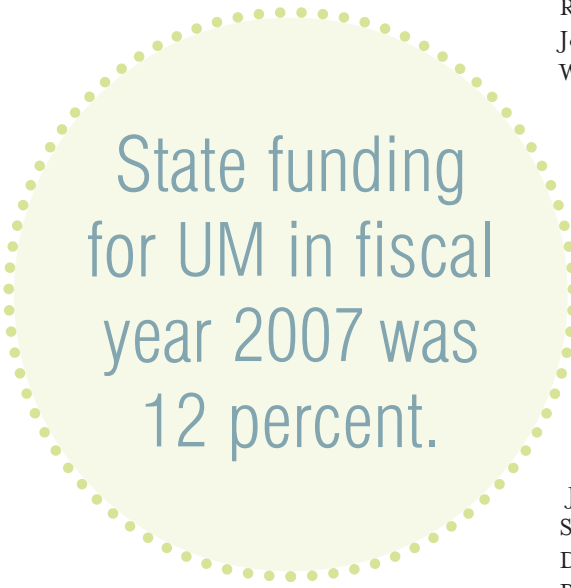

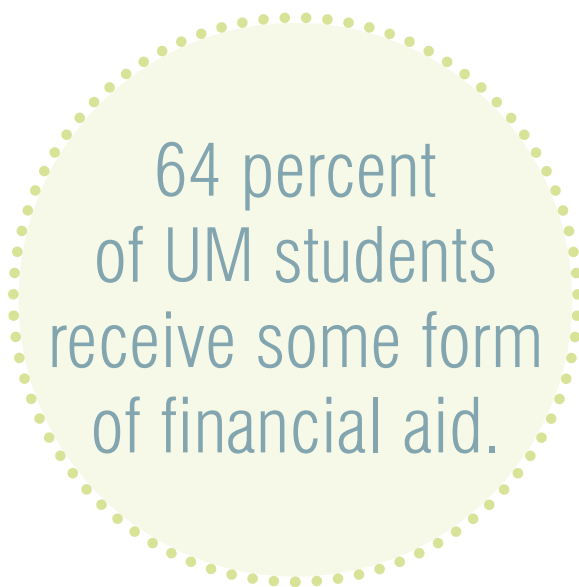
