Business Items

 The curriculum summary appended from the Science and Math Subcommittee were approved. The summary provides additional details on some of the proposals. ASCRC discussed the program modification changing the Chemistry requirement for Geosciences because the vote on the subcommittee was not unanimous. Chair Hendrix provided background information for the change. It is in alignment with the research of the department faculty and does not preclude students from taking the higher level Chemistry with a lab. The items listed below require follow-up information.

- The curriculum summary from the Social Science Subcommittee appended was approved. Two of the courses (Changing the rubric for courses in the Non-profit administration program) pending in e-curr were not approved by the Political Science Department Chair. The Political Science Department was surprised to see some of the PSCI course now listed with the NPAD rubric. This may be related to the transition of Public Administration to the Baucus Institute. The Political Science Department does not support the move. Camie will investigate whether a form was submitted last year for the NPAD rubric. [The rubric was not on the curriculum summary. However, a form was submitted to change courses for the MPA to the PAUD rubric. It included Non Profit administration courses. Apparently OCHE did not approved PAUD for those courses and recommended the NPAD rubric.] Although the proposal for a new BA in Linguistics was in the Box folder it was not on the summary because the Provost did not approve it to move forward.
- The curriculum summary appended from Biomedical Sciences was approved. The following items require follow-up. The new certificate in Speech Language Pathology includes three new courses that have not yet been proposed. ASCRC agreed to accept the late forms. The Program Modifications for Missoula College Health Professions were given conditional approval pending the resolution of issues with BIOH 104 and 105 approved last year by ASCRC, but not approved by OCHE. [OCHE is waiting for a response from Professor Henderson.] Follow-up is pending on the following course forms.

Background on the two Moratorium Proposals:

They were originally submitted in Spring 2016. Here is the summary from the ASCRC annual report for AY 2015-2016: (posted at

http://www.umt.edu/facultysenate/archives/annualreports/default.php)

"The moratorium proposals for Electronics and Energy Technology were not approved by ASCRC. ASCRC met with Missoula College Dean Shannon O'Brien and Interim Associate Dean Penny Jakes about the proposals on 3/22/16 and voted on the proposals the following week. The Science Subcommittee disapproved the moratorium proposals. After discussion, the full ASCRC committee voted against the moratorium proposals by a 7 to 1 vote with 2 abstentions. ASCRC does not base its decisions on financial need or strategic direction, but rather on academic merit. The committee feels that the programs in question are academically sound and provide employable skills in demand today. From that perspective the committee believes the moratoriums are not warranted. Placing the programs in moratorium does not appear to be the best way for these programs to succeed and grow although it does appear that the curricula may need to be modified to increase student numbers."
