#### **Communication**

- A feedback form is available for faculty to comment on the presumptive budgets, strategic
  investment, and reorganizations. Senators and Department chairs were sent a message that
  also included a link to the summary of Level I and Level II proposals and the schedule of
  subcommittee presentations to ASCRC and Graduate Council.
- Members were reminded of their Presentation dates. Two program move forms have been received and distributed to subcommittees for review. The Science Subcommittee has two program modification forms that change the advanced writing requirement for Forestry majors. Forestry has a distributed model to meet the requirement, but the list of partial advanced writing courses are not available in the catalog. Chemistry had to eliminate its advanced writing course so its students will need to find an alternative science based advanced writing course. The Writing Committee will discuss whether these courses should be listed in the catalog.

- The Hardship Withdrawal Workgroup is in the process of setting up a meeting with SARC.
- Chair Hendrix and Vice Chair Cobbs met with Associate Provost Nathan Lindsay to discuss the various Advanced Options. Another meeting is needed with representation from the Admissions Violet Hopkins and Emily Steger, Executive Director French, and the Dual Enrollment Coordinator, Jorden Patterson. To discuss how to streamline the information and facilitate entry to UM.
- The Advising Workgroup is meeting at 3:00 p.m. today.
- Eli provided an update on ASUM's UM Core Communication Committee. It set up a survey about the current general education program to get student and alumni data. Thus far the results (has been sent to the College of Science and Humanities and Business) do not indicate a general dissatisfaction with the General Education program. The Office of Student Success also has data from post advising surveys that indicates 84% of students understand the general education requirements.
- Chair Hendrix requested member's input regarding the proposed revision to the Natural Science General Education Group currently on the Faculty Senate agenda. Since it was introduced to the Senate at the last meeting, any motion to table or send back to committee should come from the floor of the Faculty Senate.

XXXX- OK. Lit 110 WAS a Y until shortly before. Advisor error is documented and petition is supported by HHP Admin. APPROVED.

XXXXX- No. Insufficient evidence that the "experience" satisfies the VIII criteria. Student still has ample time to take a course. No evidence of written papers, just discussions. DENIED.

XXXXX- Maybe. Does the graduate under the 2007 catalog? Has plenty of credits and a good GPA. Appeal is well documented. If 2007 catalog works then petition is granted by use of 2007 catalog. If not then need to substitute for the two Gen ed categories with existing courses. Which two? Jpns 202 and 395, as NW (X); Lit 120, Art 151, ENCR 210 and MAR 210 as Y. "No grad app" but grad app is included? APPROVED.

XXXX- OK. Round 38.66 up to 39 for upper div requirements. Good GPA. APPPROVED.

XXXX- OK. Accept Thtr 101 transfer from U. Idaho as Y at UM. Confirmed in 2018 catalog that course is a Y. Good GPA. APPROVED.

XXXXX- OK to use the 2003-4 catalog. Need grad app under 2003-4 catalog to prove he meets History requirements. Should get advising to double check degree requirements. Poor GPA attempted Geo/lab several times. APPROVED.
